Regular Session:

The Board of Public Works and Safety met in regular session on Tuesday, June 23, 2020 at 9:00 a.m. in the Common Council Chambers. Members present were: Gary Henriott, Cindy Murray, Amy Moulton, Ron Shriner and Norm Childress

Jacque Chosnek, 1<sup>st</sup> Deputy City Attorney, was also present.

President Henriott called the meeting to order.

The Pledge of Allegiance was given to the flag of our Country.

**MINUTES**

Mrs. Moulton moved for approval of the minutes from the June 16, 2020 regular meeting. Mrs. Murray seconded. Passed.

**BID OPENING**

*18<sup>th</sup> and Central Drainage Improvement Project*

This being the time set to open bids for the 18<sup>th</sup> and Central Drainage Improvements Project and the following bids were received and opened:

## **NEW BUSINESS**

### **Parks Department**

#### *Recommendation for Award- Loeb Stadium-Video Display Board*

Claudine Laufman, Parks Superintendent, presented to the Board and recommended approval of a Recommendation for Award for the Loeb Stadium Video Display Board. The apparent low bidder is Fair-Play Corporation with a bid in the amount of \$512,198.00. Mr. Childress moved for approval. Mrs. Moulton seconded. Passed.

#### *Contract- Loeb Stadium-Video Display Board*

Mrs. Laufman presented to the Board and recommended approval of a Contract for the Loeb Stadium Display Board with Fair-Play Corporation in the amount of \$512,198.00. Mr. Shriner moved for approval. Mrs. Murray seconded. Passed.

#### *Notice to Proceed- Loeb Stadium-Video Display Board*

Mrs. Laufman presented to the Board and recommended approval of a Notice to Proceed for the Loeb Stadium Video Display Board. The work on the project is set to begin of June 23, 2020 with final completion by December 21, 2020. Mr. Shriner moved for approval. Mrs. Moulton seconded. Passed.

#### *Change Order #1- Loeb Stadium-Video Display Board*

Mrs. Laufman presented to the Board and recommended approval of Change Order #1 for the Loeb Stadium Video Display Board with Fair-Play Corporation. The change order includes an upgrade from a 16mm pixel resolution screen to a 10mm pixel resolution screen. The total change order is an addition in the amount of \$66,549.00 which brings the revised contract amount to \$578,747.00. Mr. Childress moved for approval. Mrs. Moulton seconded. Passed.

#### *Contract-Alt & Witzig for Engineering Testing and Inspection Services*

Mrs. Laufman presented to the Board and recommended approval of a Contract with Alt & Witzig Engineering for engineering testing and inspection services for the Carousel Project. The contract is in the amount of \$6,317.25 and includes performing various quality control inspections and tests during the construction process. Mrs. Laufman stated that the scope includes, but not limited to, concrete foundations, concrete slabs, backfill compaction, floor flatness, structural steel inspection, masonry, and hardscape concrete. Mrs. Moulton moved for approval. Mrs. Murray seconded. Passed.

### **Lafayette Renew**

#### *Contract Extension with Merrell Brothers*

Brad Talley, Water Pollution Control Superintendent, presented to the Board and recommended approval of a Contract Extension with Merrell Brothers. Mr. Talley stated this is a 48 month extension for liquid land application for bio solids. This contract is a mutually agreed upon extension with the current hauling and

application rate of \$30.32 per 1000 gallons along with a fuel surcharge of \$0.007 per gallon. Mrs. Moulton moved for approval. Mr. Shriner seconded. Passed.

*Change Order #1-Service Area 21 Water and Sewer Extension Project*

Mr. Talley presented to the Board and recommended approval of a Change Order #1 for Service Area 21 Water and Sewer Extension Project with Atlas Excavating. The change order is in the amount of \$341,027.20 which brings the revised contract amount to \$4,644,970.20. The change order includes seven (7) work directive changes that have been agreed to by field staff. Mrs. Moulton moved for approval. Mr. Childress seconded. Passed.

*Amendment #1-Contract with Greeley and Hansen for Combined Sewer Overflow Term Control Plan Phase II-C*

Mr. Talley presented to the Board and recommended approval of Amendment #1 for Contract with Greeley and Hansen for the Combined Sewer Overflow Term Control Plan Phase II-C. The amendment includes general design phase, long term control plan updates, preliminary design, basis of design report, final design; and asset management phase II. The amendment is in the not-to-exceed amount of \$1,215,640.00 which brings the revised contract amount to \$1,408,140.00. Mr. Talley also presented a Midway Progress Report. Mr. Shriner moved for approval. Mrs. Murray seconded. Passed.

**Water Works**

*Change Order #1-Teal Road Water Main Relocation*

Jeromy Grenard, Public Works Director, presented to the Board and recommended approval of Change Order #1 for the Teal Road Water Main Relocation Project with Miller Pipeline, LLC. The change order is in the amount of \$1,590.00 which brings the revised contract amount to \$191,157.50. The change order includes extra cost for encountering an underground electrical line and 2" PVC drain. Mrs. Murray moved for approval. Mr. Childress seconded. Passed.

*Change Order #2-Teal Road Water Main Relocation*

Mr. Grenard presented to the Board and recommended approval of Change Order #2 for the Teal Road Water Main Relocation Project with Miller Pipeline, LLC. The change order is in the amount of \$28,554.00 which brings the revised contract amount to \$219,711.50. The change order includes installing 100ft of water main at 9ft. depth rather than 5ft. depth, additional mobilization fee due to schedule conflicts; and final quantity adjustments. Mrs. Moulton moved for approval. Mr. Shriner seconded. Passed.

*Certificate of Substantial Completion-Teal Road Water Main Relocation*

Mr. Grenard presented to the Board and recommended approval of a Certificate of Substantial Completion of the Teal Road Water Main Relocation Project dated for May 29, 2020. Mrs. Moulton moved for approval. Mr. Childress seconded. Passed.

**Engineering**

*Change Order #3 (Contractor CO#3 & CO#4)-Wabash River Promenade*

Mr. Grenard requested this item be withdrawn from the agenda. President Henriott stated he would withdraw the item from the agenda.

*Change Order #2-Twyckenham Boulevard Construction*

Mr. Grenard presented to the Board and recommended approval of Change Order #2 for the Twyckenham Boulevard Construction. The change order is in the amount of \$4,566.44 which brings the revised contract amount to \$3,493,385.42. The change order includes relocating 6” water service to Soller-Baker. Mrs. Murray moved for approval. Mr. Childress seconded. Passed.

**Purchasing**

*Declaration of Surplus Property-Fire Department*

Dave Payne, Purchasing Manager, presented to the Board and recommended approval of a Declaration of Surplus Property for the Lafayette Fire Department that includes a 2002 Pierce Contender Fire Engine VIN# 2NKMHZ8X53M386436 City ID# FD8. The vehicle is being replaced and will then be listed for sale through Brindley Mountain Fire Truck Brokers. Mrs. Moulton moved for approval. Mr. Childress seconded. Passed.

**Lafayette Police K-9 Unit**  
**Canine Ownership Transfer Agreement**

This Canine Ownership Transfer Agreement is effective June 30, 2020 in the City of Lafayette between Sergeant Joshua Saxton (Saxton) and the Lafayette Police Department (LPD) located at 20 North 6th Street, City Hall, Lafayette, Indiana, 47901, provides as follows:

WHEREAS, Saxton was the K-9 Unit handler assigned by the LPD to serve with K-9 Boyka and to care for and maintain said K-9 during off-duty hours at his residence, and

WHEREAS, the LPD wishes to retire K-9 Boyka from active service with the Police Department K-9 Unit, pursuant to LPD K-9 Retirement Procedure; and

WHEREAS, Saxton desires and has requested that the LPD transfer ownership and complete responsibility for K-9 Boyka's care, food, veterinary attention, lodging, maintenance and supervision solely to him; and

WHEREAS, the City of Lafayette and Saxton agree that it is in the best interest of the parties to transfer K- 9 Boyka's ownership and responsibility for care and supervision from the City of Lafayette to Saxton; and

WHEREAS, Saxton agrees to provide the care, food, veterinary attention, lodging, maintenance, and supervision of K-9 Boyka.

NOW, THEREFORE, the parties agree as follows:

The City will transfer sole ownership, custody, and responsibility for K-9 Boyka to Saxon, effective June 30, 2020. Saxton will accept sole ownership of said K-9 without reimbursement or compensation. Saxton warrants that he will hold the City harmless from all claims for loss, injury, damages and liability of whatever kind, caused or alleged to be caused by K-9 Boyka, after June 30, 2020, whether Saxton, or any other person, is deemed negligent or alleged to be negligent or not, with respect to care, control, supervision, and maintenance of K-9 Boyka.
