

**ORDINANCE 2023-28**

**An Ordinance to Amend  
Ordinance 2022-36**

**An Ordinance Fixing the Salaries of the Appointed Officers and Employees  
Of the City of Lafayette, Indiana, for the Year 2023,  
Excluding the Sworn Protective Occupation and Law Enforcement Members of  
The Police and Fire Departments**

WHEREAS, the Common Council of the City of Lafayette, Indiana adopted Ordinance 2022-36, An Ordinance Fixing the Salaries of the Appointed Officers and Employees of the City of Lafayette, Indiana for the Year 2023, Excluding Sworn Protective Occupation and Law Enforcement Members of the Police and Fire Departments; and

WHEREAS, the Mayor and Police Chief have determined the needs of the City will be best served by adding two new Community Service Officer positions within the Police Department which will be civilian positions to supplement the efforts of a sworn officer when a sworn officer is not required; and

WHEREAS, the Mayor has consented to the proposed changes; and

NOW THEREFORE, Be it Ordained by the Common Council of the City of Lafayette, Indiana:

1. Exhibit "A" of Ordinance 2022-36, An Ordinance Fixing the Salaries of the Appointed Officers and Employees of the City of Lafayette, Indiana for the Year 2023, Excluding Sworn Protective Occupation and Law Enforcement Members of the Police and Fire Departments, is hereby amended to add two new Community Service Officer positions within the Police Department as follows:
