

Historic Preservation Commission Meeting Minutes

Noting a quorum, President John Burns called the meeting of the Lafayette Historic Preservation Commission to order at 7:00 pm.

Approval of the March 2019 Minutes

Kurt Wahl moved to recommend approval of the minutes of the March 2019 meeting. Julie Ginn seconded the motion. The motion passed unanimously.

COA Committee report

COA applications:

North-south sidewalk and crosswalk on the west side of 11th Street at Main Street

John Collier spoke on behalf of the City. The City is redoing this intersection to address storm water/flooding issues at the buildings on the north side of Main Street. They will be removing existing precast concrete pavers (that are not historic) and replacing them with similar precast concrete pavers except that the new pavers will be pervious to assist with infiltration of storm water. The concrete walk on the North West corner will be modified with additional concrete to accommodate a new handicapped ramp that will be further to the north than the existing ramp. The crosswalk across Main Street and the sidewalks on the west side of 11th are in the local historic district, the remaining part of the project is outside the limits/authority of the Historic Preservation Commission. Dann Keiser stated the requested changes meet Secretary of Interior standards.

Julie Ginn moved to approve the COA for North-south sidewalk and crosswalk on the west side of 11th Street at Main Street as submitted. Sean Lutes seconded the motion. The motion passed unanimously.

Staff Report

John Collier passed out Indiana DNR posters highlighting Mid-Century architecture to Commission members.

He also reviewed COAs for signs that were approved by staff in the past month.

Patti Morgan discussed an education opportunity with the commissioners regarding historic window restoration using windows on the second floor of her building for the workshop. Tim Storey will lead the

recurring workshop that will take place throughout the month of June. Anyone interested in historic window restoration is invited to attend. Patti Morgan mentioned that she thought Purdue Construction Management students would find this very interesting...


Public Comment/ Adjournment
