Lafayette Arts Center Stage dedicates first two public art installments Place Based Investment Fund Grant makes downtown a celebration of arts and culture

LAFAYETTE, IN - November 5, 2015 - Earlier this year Lafayette was awarded \$50,000 from Indiana's Place Based Investment Fund (PBIF), a partnership between the Indiana Office of Community and Rural Affairs (OCRA) and the Indiana Office of Tourism Development (IOTD). The fund is dedicated to encouraging community partnerships as they work together to make their hometowns become even greater places to visit, live and work. Shortly after receiving the grant, work groups were established to help implement the Lafayette Arts Center Stage projects and bring in more members of the community that could further define these qualities of place to attract residents and visitors alike.

Lafayette Arts Center Stage is a series of bicentennial-themed public art installations combined as one project, located along Main Street in downtown Lafayette's art and culture districts. Today we dedicate the first two installments of the Lafayette Arts Center Stage project - the Seurat Mural by artist Zach Medler at 219 Main Street and the Art Crosswalk, a collaboration design by artists Petronio Bendito and Linda Vanderkolk at 10th and Main streets.

City planner and project manager for Lafayette Arts Center Stage, Margy Deverall, emphasizes the connection this public art has with local artists and collaboration. "The two projects being dedicated are both by local artists. The Seurat inspired mural at 219 Main, by Zach Medler, refreshed the "small spaces: Lafayette" index wall from 2014. The Fleur-de-lis Art Crosswalk at 10th and Main, designed by Petronio Bendito and Linda Vanderkolk, turned into a community project with over 75 people painting with stencils during two Mosey Down Main Street events."

Leaders from the Indiana Office of Community and Rural Affairs and the Indiana Office of Tourism Development are excited to be part of the this PBIF art dedication for Lafayette. "OCRA and IOTD are both dedicated to improving the quality of place in Indiana through the PBIF program," said Bill Konyha, executive director of the Office of Community and Rural Affairs. "The Lafayette art installation illustrates the community's commitment to being an even better place to visit, live, and work. Thanks to the collaboration of many, Lafayette is primed to thrive in the 21st century and is positioned for continued economic growth."

"In order to be a great place to visit, a city must first be a great place to live, and PBIF was created with that idea in mind," said Mark Newman, executive director of the Indiana Office of Tourism Development. "We're excited to have this new public art installation in Lafayette, adding to an already impressive list of assets in the community."

"Through this grant Indiana has given our community a wonderful opportunity to showcase our creative side.
