**SPECIAL LAFAYETTE HEARING AUTHORITY**  
**February 20, 2018**

The Lafayette Hearing Authority met on Tuesday, February 20, 2018 at 9:15 a.m. in the City Council Chambers of Lafayette City Hall. Present were: Gary Henriott, Ron Shriner and Cindy Murray

Jacque Chosnek, 1<sup>st</sup> Deputy Attorney, was also present.

Mr. Shriner called the meeting to order.

**MINUTES**

Mr. Henriott moved for approval of the July 25, 2017 minutes. Mrs. Murray seconded. Motion Carried.

Mr. Henriott asked about the status of 1327 Columbia Street and 615 Wabash Avenue. Mrs. Chosnek stated that both structures were demolished and sent out the initial notice necessary before certifying the costs to go on the tax duplicate.

**NEW BUSINESS**

*Petition to Declare Property Abandoned-1812 Perrine Street*

Mrs. Chosnek gave the Board a brief description of the process declaring these properties abandoned. Mrs. Chosnek recommended declaring 1812 Perrine Street as abandoned. The structure has windows and entrances that are boarded up or closed off, broken or unrepaired and the property is deteriorating. The property is below or in emanate danger of falling below the minimum community standards for public safety and sanitation. The property owner was notified by publication in the Journal & Courier on January 30<sup>th</sup> & 31<sup>st</sup>, 2018. The mortgage company was notified by certified mail on January 29, 2018. Mrs. Murray moved for approval. Mr. Henriott seconded. Motion Carried.

*Petition to Declare Property Abandoned-1402 Johnson Drive*

Mrs. Chosnek requested withdrawing this property from the agenda. Mrs. Chosnek stated that her office has received confirmation by the owner that the property is not abandoned.

*Petition to Declare Property Abandoned-3888 Penbrook Lane*

Mrs. Chosnek recommended declaring 3888 Penbrook Lane as abandoned. The structure has windows and entrances that are boarded up or closed off, broken or unrepaired and the property is deteriorating. The property is below or in emanate danger of falling below the minimum community standards for public safety and sanitation. The property owner was notified by publication in the Journal & Courier on January 30<sup>th</sup> & 31<sup>st</sup>, 2018. The mortgage company was notified by certified mail on January 29, 2018. Mr. Henriott moved for approval. Mrs. Murray seconded. Motion Carried.

*Petition to Declare Property Abandoned-516 S. 1<sup>st</sup> Street*

Mrs. Chosnek recommended declaring 516 S. 1<sup>st</sup> Street as abandoned. The structure has windows and entrances that are boarded up or closed off, broken or unrepaired and the property is deteriorating. The property is below or in emanate danger of falling below the minimum community standards for public safety and sanitation. The property owner was notified by publication in the Journal & Courier on January 30<sup>th</sup> & 31<sup>st</sup>, 2018. The interested parties notified by certified mail on January 26 & February 5, 2018. Mrs. Murray moved for approval. Mr. Henriott seconded. Motion Carried. Discussion Ensued.

*Petition to Declare Property Abandoned-1300 Cincinnati Street*

Mrs. Chosnek requested withdrawing this property from the agenda. Mrs. Chosnek stated that she has been in contract with the property owner.
