## LEGAL DESCRIPTION OF LOCAL PERRIN/613 PERRIN AVENUE HISTORIC DISTRICT

Lot Numbered One Hundred Twenty-eight (128) in Perrin's Addition to the City of Lafayette, as platted upon a part of the southwest quarter of Section Twenty-one (21) in Township Twenty-three (23) North, Range Four (4) West.

EXCEPT: Part of Lot 128 and the northern half of the vacated Tinkler Street in Perrin's Addition to the City of Lafayette, as recorded in Deed Book 61, page 36, in the Office of the Recorder for Tippecanoe County, Indiana, located in Section 21, Township 23 North, Range 4 West in Fairfield Township, Tippecanoe County, Indiana, more particularly described as follows: Beginning at the southwestern corner of the said Lot 128; thence North 31° 41' 16" West along the western line of said Lot 128 for 100.83 feet; thence North 65° 00' 00" East for 95.26 feet to the eastern line of said Lot 128; thence South 31° 16' 44" East along the said eastern line and its southern extension for 125.75 feet to the centerline of the vacated Tinkler Street; thence South 65° 00' 00" West along the said centerline for 94.36 feet to the southwardly extension of the western line of said Lot 128; thence North 31° 41' 16" West along the southwardly extension of the western line of said Lot 128 for 25.02 feet to the point of beginning.
