

**Ordinance No. 2022-13**

AN ORDINANCE FOR  
FOR ADDITIONAL APPROPRIATION  
AND FOR TRANSFER OF APPROPRIATIONS BETWEEN MAJOR BUDGET  
CLASSIFICATIONS IN THE POLICE CONTINUING EDUCATION FUND  
(FUND #2320)
