

**ORDINANCE 2023-14**

**An Ordinance to Amend  
Ordinance 2022-36**

**An Ordinance Fixing the Salaries of the Appointed Officers and Employees  
Of the City of Lafayette, Indiana, for the Year 2023,  
Excluding the Sworn Protective Occupation and Law Enforcement Members of  
The Police and Fire Departments**

WHEREAS, the Common Council of the City of Lafayette, Indiana adopted Ordinance 2022-36, An Ordinance Fixing the Salaries of the Appointed Officers and Employees of the City of Lafayette, Indiana for the Year 2023, Excluding Sworn Protective Occupation and Law Enforcement Members of the Police and Fire Departments; and

WHEREAS, the Mayor and Parks Superintendent have determined the needs of the City will be best served by adding a Zoo Educator position within the Parks Department; and

WHEREAS, the Economic Development Director has requested a change in name only of the position currently titled “Senior Planner/Project Manager” to “Senior Community Development Manager”; and

WHEREAS, the Mayor has consented to the proposed changes; and

NOW THEREFORE, Be it Ordained by the Common Council of the City of Lafayette, Indiana:

1. Exhibit “A” of Ordinance 2022-36, An Ordinance Fixing the Salaries of the Appointed Officers and Employees of the City of Lafayette, Indiana for the Year 2023, Excluding Sworn Protective Occupation and Law Enforcement Members of the Police and Fire Departments, is hereby amended to add the following positions within the Parks Department:

2. Exhibit “A” of Ordinance 2022-36, An Ordinance Fixing the Salaries of the Appointed Officers and Employees of the City of Lafayette, Indiana for the Year 2023, Excluding Sworn Protective Occupation and Law Enforcement Members of the Police and Fire Departments, is hereby amended to change the name of the “Senior Planner/Project Manager” within the Economic Development Department to “Senior

Community Development Manager”. The change is in title only and the position shall remain classified as a PAT IV.

3. All other terms and provisions of Ordinance 2022-36, An Ordinance Fixing the Salaries of the Appointed Officers and Employees of the City of Lafayette, Indiana for the Year 2023, Excluding Sworn Protective Occupation and Law Enforcement Members of the Police and Fire Departments, as previously amended by Ordinance 2022-50 and Ordinance 2023-01, shall remain in full force and effect.
