Incumbent serves as the Stormwater Educator for the Tippecanoe County Partnership for Water Quality (TCPWQ), responsible for designing and delivering educational programs, with a focus on adult education, monitored by Lafayette Renew.

- Bachelor of Science degree in Natural Resource and Environmental Management, Environmental and Ecological Engineering, or equivalent training and/or experience.
- Ability to effectively complete all OSHA required safety training.
- Ability to work well alone under minimal supervision and with others in a team environment.
- Working knowledge of developing and implementing curriculums regarding natural resource and ability to manage and facilitate various educational programs.
- Ability to use word processing, database management and accounting software programs as applicable, computer, calculator, facsimile, copy machine, typewriter, two-way radio, base radio, radio phone, and other common office equipment.
- Ability to effectively communicate orally and in writing with co-workers, TCPWQ Partnership, Wabash River Enhancement Corporation, various schools and watershed groups, and the public.
- Ability to plan and layout assigned work projects and plan and present public speaking presentations and special events.
- Ability to serve on committees as needed.
- Ability to occasionally work extended, evening, weekend hours, and travel for conferences, meetings, and presentations.
- Ability to be a self-starter, have excellent organizational skills, and detail oriented.

- Designs curriculum and delivers presentation on various environmental education topics, including facilitating workshops, classroom presentations and activities.
- Develop and implement water quality educational programs.
- Oversee compliance with federal mandates, specifically Minimum Control Measure I Public Education and Outreach and II Public Participation of the National Pollutant Discharge Elimination System Phase II of the Clean Water Act.
- Compiles, organizes, and composes various materials, reports, and correspondence.
- Attends various meetings as required.
- Performs related duties as assigned, and assists in other areas as needed.
- Develop marketing materials for TCPWQ.
- Maintains detailed records and filing systems.
- Researches information for various reports and projects.
- Collaborates with Wabash River Enhancement Corporation (WREC) and various other groups, and serve on committees.
- Performs related duties as required.
- Must hold a valid Indiana Driver's License and demonstrated safe driving record.
